#### Purpose of MoU:

**Responsibilities of College:**

College will be responsible for:

- Providing the necessary infrastructure and facilities for the lectures during Offline sessions
- Identifying and motivating students to register for the course
- Assigning a permanent coordinator for entire course
- Ensuring the attendance and participation of the students in the lectures
- Providing full support for promotional/branding activities like (related to the course) posters, banners, handbills, pamphlets, brochures, standees, college notice board, competitions and advertising gates etc.
- Providing feedback to Maargeen Consultancy Private Limited on the quality and effectiveness of the lectures

**Duration:**

This MoU will be effective for a period of One Year. It may be extended or terminated by mutual agreement of the parties.

**INTELLECTUAL PROPERTY RIGHTS:**

Each party shall continue to own the intellectual property developed prior to or independently of this Memorandum of Understanding.



All rights, title and interests in and to the material used by Maargeen Consultancy in the provision of the services of this Agreement shall exclusively belong to Maargeen Consultancy or its licensors ("Maargeen Proprietary Material"). Any and all Intellectual Property Rights with respect to the Services and the Maargeen Proprietary Material and all modifications, improvements, enhancements, or derivative works made thereto, shall always belong to Maargeen Consultancy and the College shall not be entitled to claim any rights therein. All rights, title and interests in data of College shall always remain with College. College agrees that Maargeen Consultancy shall have the right to list College name in its marketing material and use logo with respect to the College such Listing and for reference purposes related to the said free course only being provided to students of the approved College. College acknowledges that the provision of the services hereunder by Maargeen shall be on a non-exclusive basis and Maargeen shall be free at all times to provide the services or perform obligations same or similar to the Services and obligations envisaged hereunder to any of its other clients/colleges, either existing or future, and nothing herein shall preclude Maargeen from providing such services or performing such obligations to its other clients/colleges.

#### PRECLUDED FROM:

The parties agree that they are not bound exclusively by this memorandum and will be at liberty to enter into any other agreements or arrangements with any third party without reference to the other party in this MOU on the similar program (s).

#### III) CONFIDENTIALITY

During the term of this MOU, each Party may disclose to the other its Confidential Information. Confidential Information shall mean all information marked "Confidential" or under any similar legend indicating the confidentiality of the information or information which by its nature is confidential, except such information as is (a) previously known to the receiving party at the time of disclosure, or (b) independently developed by or for the receiving party and not derived from the Confidential Information supplied by the disclosing party or the participation of individuals who have had access to Confidential Information of the other, (c) disclosed to the receiving party by a third party without an obligation of confidentiality or (d) in or subsequently comes into the public domain [other than as a result of a breach of this MOU]; (e) required to be disclosed by the receiving party by law, regulation, court order or other legal process.

#### Governing Law and Jurisdiction:

This MoU will be governed by and construed in accordance with the laws of India and any disputes arising out of or in connection with this MoU shall be subject to the exclusive jurisdiction of the courts of Thane.

Entire Agreement:

This MoU constitutes the entire agreement between Maargeen Consultancy Private Limited and Arts and Commerce College Undale with respect to the subject matter hereof and supersedes all prior negotiations, understandings, and agreements, whether written or oral, relating to such subject matter.


Amendments:

This MoU may be amended or modified only in writing and signed by both parties.
