

During the period of MOU, both the institute/organizations would cooperate and collaborate with each other in the identified areas of mutual interest for mutual development as detailed under.

Areas of Collaboration/interaction-

On its parts, the institute/Organization shall consider and try, to the extent possible-

- To share knowledge and expertise of the Researchers, students, facultiesandother members of both the organizations on case to case basis with mutual consent.
- To provide resource persons for guest lecture/workshop etc.at the students and faculty development programs and research assignments of mutual interest.
- To grant permission for visit of faculty members and the students to the Institute / Organization as per mutually convenient dates and schedule.
- To offer testing and other technical facilities available with the institute/Organization if required by the members of institute/Organization.
- To offer technical consultancy/training as per the need of both organization.
- 6) To offer the library/ infrastructure/other amenities/facility of the institute to the company/ organization personnel if required by the company/organization as per a procedure which is mutually evolved.

Common points of consideration-

- The MOU does not imply any kind of financial obligation, unless agreed upon in writing, on either side and neither party can claim for any financial charges.
- The association and activities carried out through the MOU should never be considered
 as an employment opportunity in any course of time by any individual concerned.
- 3) The MOU does not bind or compel either party to provide for the above mentioned favours to the other party and rather aims to build and foster a spirit of Collaboration for the mutual benefit while protecting the individual and mutual interests.

- 4) The MOU shall be effective from the date of signing/approval through official mail and either party can terminate this arrangement by a simple written communication by a competent authority at any point of time.
- 5) Neither party shall be liable for any indirect, punitive, special, incidental or consequential damages arising out of or in connection with this understanding, whether for breach of this MOU or in torts, including loss of business, data, revenue and profits or for any third party claims against the other whatsoever.
